



## **IEG Good Practice Awards 2010**

1 October 2010

Every year, the Independent Evaluation Group (IEG) awards World Bank and International Finance Cooperation (IFC) projects and country programmes, which demonstrate exemplary design and implementation, as well as excellence in self-evaluation. The purpose is to create incentives among staff for greater development effectiveness. The 2010 Good Practice Awards were presented following the IEG annual Evaluation Week, designed to increase awareness of IEG's work and products, and to share knowledge on how evaluation can be useful in development. The winners of the 2010 Awards were divided into the following categories:

### **Project Award: Peru Second Rural Roads Project for gender Dimension**

This project demonstrated the effective involvement of women in the decision-making and design of a road project, which resulted in a more efficient construction for women's mobility, safety, and time management, and allowed them to obtain new sources of income.

### **Country Program Award: Georgia Country Program**

The Bank's strategy in Georgia was centred on the government's reform agenda. There, it played an important and constructive role in the international response to Georgia's two crises, the global financial crisis and the conflict with Russia in August 2008, through both financial assistance and convening power.

### **ICR Quality Awards: Mali PRSC I and II ICR and Ukraine TB/HIV/AIDS Control Project ICR**

The ICR for Mali's PRSC I and II provided a clear presentation of what was achieved in terms of prior actions and performance indicators, including an assessment of the relevance of the performance indicators. The ICR for the Ukraine TB/HIV/AIDS Control Project is commended for its efforts to learn lessons from an unsatisfactory project.

### **CASCR Quality Awards: CASCR for the OECS Countries**

The CASCR for the Organization of Eastern Caribbean States (OECS) was applauded for its quality of the evidence and analysis, and its coverage and clarity, for each of the six countries involved.

### **Influential Analytical Work Awards: Uganda 2007 Public Expenditure Review**

The Uganda 2007 PER contributed to shifts in budget allocations and greater emphasis on operational efficiency in government.

### **Monitoring and Evaluation Awards: Assessing Results Measurement at the World Bank, A Case Study from the Latin America and Caribbean Region Human Development Department**

The review of results monitoring in the LCSHD portfolio assessed the frequency with which key indicators are effectively measured in project supervision and diagnosed problems at the Departmental and Bank levels.
