Birkbeck, University of London. His research focuses on the design of monetary and fiscal policies, climate economics, and structural issues.
Julie KOZACK Head of the Communications Department (COM) at the International Monetary Fund
As Director of the Communications Department, Ms. Julie Kozack is responsible for IMF strategy on external engagements with media and the Fund's key stakeholders, including legislatures and parliaments, labor representatives, civil society groups, and academics, as well as the Fund's internal communications. The Director works closely with the Managing Director and senior IMF management on the communication of the institution's operations, including policy and lending decisions. Ms. Kozack was previously a Deputy Director in the European Department (EUR), where she oversaw the IMF's work on Ukraine. Prior to that, she was a Deputy Director in the Western Hemisphere Department (WHD) and lead negotiator for Argentina on its program. Ms. Kozack has also worked in the Fund's Research and Strategy and Policy Review Departments. She has been mission chief for Germany, Iceland (during the crisis program period), Lithuania, Poland, and deputy mission chief for Russia. Ms. Kozack was heavily involved in multilateral surveillance work, particularly on G20 and G7 engagement at the time of the global financial crisis. Ms. Kozack further leveraged her leadership and communications expertise in her three-year role as the Director of the Singapore Regional Training Institute,

demonstrating her seasoned managerial and
leadership skills, running an independent institute away from headquarters with a mix of headquarter,
local, and expert staff. She oversaw the delivery of
training and capacity development to the Asia- Pacific region and broadened the understanding of
the Fund by engaging with parliamentarians in the
region through workshops and other training
forums, as well as public and press engagements. Ms. Kozack, a United States national, holds a PhD
as well as two master's degrees in economics from
Columbia University, New York. She earned a BA

Kristalina Georgieva has served as Managing
Director of the International Monetary Fund since
2019 and began her second term in 2024. In her first term, Ms. Georgieva led the IMF's response to
multiple global shocks: the pandemic, war, and an
inflation surge. During that time, the IMF injected
about \$1 trillion in reserves and liquidity, including through a historic \$650 billion allocation of SDRs,
and engaged in lending to nearly 100 member
countries. It adopted a first-ever climate strategy
and created the Fund's first long-term lending instrument – the Resilience and Sustainability Trust.
In 2023, the IMF completed its 16th Review of
Quota, resulting in an agreement to increase quota
shares of member countries by 50 percent. Ms.
Georgieva's tenure at the IMF has also been marked by progress on diversity, equity and inclusion,
including the addition of a third Sub-Saharan
African Chair to the IMF Board and increased
regional diversity and gender balance among IMF management and staff. Before joining the IMF, Ms.
Georgieva was CEO of the World Bank. Previously,
Ms. Georgieva served as European Commission
Vice President for Budget and Human Resources
overseeing the EU's €161 billion (US \$175bn) budget and 33,000 staff, as well as the EU's
response to the Euro Area debt crisis and the 2015
refugee crisis. Before that, she was Commissioner
for International Cooperation, Humanitarian Aid

and Crisis Response, managing one of the world's largest humanitarian aid budgets. Ms. Georgieva serves on many international panels including as co- Chair of the Global Commission on Adaptation, co- chair of the United Nations Secretary-General's High-Level Panel on Humanitarian Financing, a member of the Board of Trustees of the World Economic Forum and a member of the Steering Committee of the Paris Peace Forum. She has authored and co-authored over 100 publications on environmental and economic policy, including textbooks on macro- and microeconomics. Her early career included numerous senior roles at the World Bank after starting as an environmental economist in 1993. Born in Bulgaria and holding a Ph.D. in Economic Science, she has published extensively and received multiple international awards for her leadership and contributions to global cooperation.
Ranjit SINGH Assistant Director within the Monetary and Capital Markets DepartmentRanjit Singh advises the IMF and governments on financial stability, market regulation and ESG risk. He is an experienced international policymaker and former academic with 25 years of experience in capital market development, policy, and regulation focusing on Emerging Markets countries and Asia. # Ajay BANGA

President of the World Bank Group

Ajay Banga is the President of the World Bank Group, beginning his five-year term on June 2, 2023. He stepped into the role with a clear mandate: to transform the 80-year-old institution into a faster, more efficient, and more impactful partner in development.

Since taking office, Ajay has led the adoption of a new vision and mission for the World Bank: to create a world free of poverty—on a livable planet. Under his leadership, the Bank has undertaken a broad set of reforms to boost lending capacity, simplify operations, and deliver development solutions that are practical, scalable, and impactful. He has prioritized a more agile institution—one that is easier to work with and focused on getting results.

At the core of Ajay's agenda is a belief that job creation is the most powerful driver of development—offering not just income, but dignity and purpose. That conviction has helped shape new efforts to connect 300 million Africans to electricity by 2030, expand access to quality and affordable healthcare for 1.5 billion people, and develop a modern approach to agribusiness that can drive growth, improve food security, and create economic opportunity.

Ajay has also brought renewed focus to harnessing the power of the private sector. He has strengthened collaboration with development partners, philanthropies, and investors, and launched the Private Sector Investment Lab—bringing together leading CEOs and asset managers to tackle the barriers holding back private capital in emerging markets. His approach reflects a fundamental shift: development progress at scale cannot be achieved without the innovation, financing, and execution capabilities of the private sector.
Prior to joining the World Bank, Ajay was Vice Chairman at General Atlantic and, before that, President and CEO of Mastercard. There, he led a global workforce of nearly 24,000 and made financial inclusion a core part of the company's strategy. He also founded the Mastercard Center for Inclusive Growth to advance equitable and sustainable economic opportunity.
Ajay's leadership extends beyond the private sector. He served as Chairman of the International Chamber of Commerce (2020–2022), and has held board roles with the American Red Cross, Kraft Foods, and Dow Inc. He is also a co-founder of the Cyber Readiness Institute. His contributions have earned wide recognition, including the Singapore Public Service Star award (2022), the Padma Shri from the President of India (2016), the Foreign Policy Association Medal (2012), and the Ellis Island Medal of Honor.
Axel VAN TROTSENBURG Senior Managing Director of Development Policy
Axel Van Trotsenburg directs the World Bank's core development work captured by its five verticals – People, Planet, Prosperity, Infrastructure and Digital Transformation – and ensures its integration into operations, with a special focus on climate change, fragility, human capital, and debt sustainability issues. He currently co-leads the Evolution Roadmap aimed at increasing the scale and impact of World Bank operations and oversees the Bank's numerous partnerships including with the UN, international financial institutions (IFIs), and bilateral partners. Prior to this, Mr. van

Trotsenburg was the Managing Director of Operations for 3.5 years, from October 2019 to April 2023. He holds a master's and a Doctorate degree in Economics and a master's degree in international Affairs.
Christine QIANGGlobal Director of Digital Core at the Digital Transformation Vice PresidencyChristine Qiang leads a team focused on establishing the foundations and enablers necessary for digital transformation in developing countries, aiming to drive shared prosperity and reduce poverty. Her team advises policymakers and regulators, collaborates with private sector and
development partners, and designs investment and technical assistance programs to expand broadband connectivity, strengthen digital safeguards such as cybersecurity and data protection, and harness AI and emerging technologies to tackle development challenges. Additionally, the team works to leverage digital technologies to promote environmental sustainability and close the digital gender gap.
Christine joined the World Bank Group in 1998. Before assuming her current role, she served as the Director of the Digital Development Global Practice, Practice Manager in the Finance, Competitiveness and Innovation (FCI) Global Practice for West and Central Africa, Practice Manager of the Global Investment Climate unit in FCI, and Practice Manager of the Global Investment and Competition Unit in the Macroeconomics, Trade and Investment (MTI) Global Practice. She also held the position of Lead Economist at the Policy Division of the Global ICT Department.
During her tenure, Christine edited the first two Global Information and Communications Reports (2006, 2009) and oversaw the publication of the first two Global Investment Competitiveness Reports (2017/18 and 2019/20) as well as the first two Digital Trends and Policies Reports (2023 and 2025). She has authored many journal articles, book chapters, reports and blogs on topics including AI,

cybersecurity, broadband investment, private sector development, IT-enabled services, trade, foreign
direct investment, competition, regulatory reforms,
productivity and competitiveness.
Christine holds a Ph.D. in Economics and a master's
in computer science and engineering from the Johns
Hopkins University.

Makhtar Diop is the Managing Director of the International Finance Corporation (IFC), the largest development institution focused on the private sector in emerging markets. Since taking office on March 1, 2021, Diop has championed private sector-driven development to align with the World Bank Group's mission of reducing poverty and promoting shared prosperity. His leadership has emphasized sustainable and inclusive growth, particularly addressing challenges like poverty, inequality, and climate change. Diop has prioritized scaling investments in critical sectors such as infrastructure, digital economy, healthcare, and renewable energy. He advocates for innovative financing solutions, including blended finance and public-private partnerships, to attract private capital to high-impact projects. This approach has enabled the IFC to mobilize billions in investment, especially in regions with limited capital access and those affected by conflict. A strong advocate for financial inclusion, Diop focuses on expanding access to financial services for women, small businesses, and rural communities, while advancing digital infrastructure. He has also significantly increased IFC's commitment to climate action, supporting green finance initiatives that reduce carbon emissions and enhance climate resilience. Before leading the IFC, Diop served as the World Bank's Vice President for Infrastructure and Africa. His career spans both public and private sectors, having served as Senegal's Minister of Economy and Finance.

Norman Loayza currently supervises the flagship data and reports, Women, Business and the Law, Enterprise Surveys, Global and Subnational Business Ready, the successor to the discontinued Doing Business.
Previously, he was a Lead Economist in the Development Research Group and managed the Asia hub of the Research Group, based in Malaysia. He was director of the World Development Report 2014, Risk and Opportunity: Managing Risk for

Development. His research has dealt with various areas of economic and social development, including macroeconomic management, economic growth, microeconomic flexibility, private and public saving, financial depth and stability, natural disasters, and crime and violence. His advisory experience at the World Bank has also ranged across different topics in various regions and countries. A few examples include business environment and economic performance in Latin America; informal and formal labor markets in the Middle East and Northern Africa; public infrastructure gaps in Pakistan and Egypt; savings for macroeconomic stability and growth in Sri Lanka, Georgia, and Egypt; and pro-poor growth in Indonesia and Peru. On external service from the World Bank, he was a Senior Economist at the Central Bank of Chile (1999-2000), where he advised on financial and monetary policy.

Norman has edited 10 books and published dozens of papers in professional journals and edited volumes. A Peruvian national, he holds a Ph.D. in economics from Harvard University (1994).

Hon. Neila Tazi has been a Senator in the Moroccan House of Counselors since 2015, where she was the first woman Vice-President of the Senate from 2016 to 2018, and the first to chair plenary sessions. She also serves as the Chair of the Foreign Affairs Committee at the Chamber of Councilors.

She was born in Washington DC where her father was an Executive Director at the World Bank in the late 1960s, giving her a life-long connection to the World Bank. She is the Chair of the Moroccan Chapter of the Parliamentary Network (PN) and

frequently plays an active role in PN global and regional activities. Ms. Tazi was elected as President of the Federation of Cultural and Creative Industries in February 2019. In 1998 she founded the Essaouira Gnaoua and World Music Festival.

A former Cabinet minister, Liam served as Chancellor of the Duchy of Lancaster in No 10 Downing Street during the Great Financial Crisis, and in Her Majesty's Treasury where, as Chief Secretary to the Treasury, he designed Labour's fiscal consolidation strategy. In Opposition, Liam served in a number of frontbench positions, chaired Labour's Policy Review, served on the Council of Europe and founded the All-Party Parliamentary Group on Inclusive Growth, which he chairs.

A former Fulbright scholar at the Harvard Business School, Liam has written twenty books, chapters and pamphlets about economic history, development and foreign affairs. His history of British capitalism Dragons: Ten Entrepreneurs Who Built Britain was published in 2016. He is also the author of Black Flag Down: Counter Extremism, Defeating ISIS and Winning the Battle of Ideas; and Turning to Face the East: How Britain Prospers in the Asian Century. Liam is one of Westminster's leading authorities on China, helped kickstart the Economic & Finance

Dialogue, and co-founded the UK-China Young Leader's Roundtable.
