## Alessandro GULLO

Assistant General Counsel, Legal Department, IMF

Alessandro Gullo is Assistant General Counsel in the IMF's Legal Department, where he leads the Financial and Fiscal Law Division. He advises IMF member countries on monetary, financial, and fiscal law reforms in the context of financial assistance programs, financial sector assessments, and technical assistance projects.

During the global financial crisis, Mr. Gullo played a central role in advising EU countries on bank resolution and crisis management frameworks and contributed to the design of the EU Banking Union. He has authored numerous papers on financial safety nets, crisis management, and governance frameworks in various regions, and served on international committees, including those of the Financial Stability Board and UNIDROIT, shaping global standards on financial institution resolution and insolvency.

Julie Kozack is the Director of the Communications Department at the International Monetary Fund (IMF). In this role, she oversees the Fund's strategy for external engagement with the media and key stakeholders—including legislatures and parliaments, labor representatives, civil society organizations, and academics—as well as internal communications. She works closely with the Managing Director and senior IMF management to communicate the Fund's operations, including policy and lending decisions.




# **Tristan WALKER**

# Layna MOSLEY

Professor of Politics and International Affairs, Princeton University

Layna Mosley is a professor of politics and international affairs in the Princeton School of Public and International Affairs and the Department of Politics. She directs the Princeton Sovereign Finance Lab, part of the Niehaus Center for Globalization and Governance. She directs the Princeton Sovereign Finance Lab, part of the Niehaus Center for Globalization and Governance.

Mosley's research investigates the connections between domestic politics and the global economy. Much of her research focuses on the politics of sovereign debt, and on how professional investors evaluate and react to political institutions and government policy choices. She also investigates how low- and middle-income governments manage their relationships with creditors, including how they decide whether to borrow from commercial banks or bond investors, and how they market themselves to potential creditors. Another stream of Mosley's work examines the effect of multinational production and global supply chains on workers' rights in developing countries, as well as the ways in which U.S. trade policies might affect workers' rights abroad. With respect to labor rights, she also is interested in efforts at private sector governance, such as the Bangladesh Accord on Building and Fire Safety.

Sven Clement, MP is a Member of Parliament for Luxembourg's Center district since October 2018, representing the Pirate Party. Born in Luxembourg City in 1989, he holds a Bachelor of Science in Information Systems from Saarland University and a Professional Development Certificate in Parliamentary Governance from McGill University. As an entrepreneur and technology leader, Clement co-founded and serves as CEO of AccountTech and Clement & Weyer Consulting, developing digital solutions for accounting, tax preparation, and compliance systems. His dual expertise in technology and governance uniquely positions him to bridge the digital transformation challenges facing modern parliamentary oversight.

In parliament, Clement serves as President of the verification of powers committee and is a spokesperson on multiple committees including Foreign Affairs, Finance, and Digitalisation. Internationally, he serves as a Board Member of the Parliamentary Network on the World Bank & IMF, Co-Chair of the Global Young MP Initiative, and holds positions in the NATO Parliamentary Assembly and OECD Global Parliamentary Network.

### Hon. Aissata Tall Sall

MP, Senegal, Vice Chair of the Parliamentary Network on the World Bank & IMF.

Hon. Aissata Tall Sall is a lawyer by training since 1982, she specializes in business law and leads a multi-partner firm. She has practiced internationally, including across Africa.

She began her political career young, serving as Minister of Communication and Government Spokesperson under President Abdou Diouf in 1998. After the 2000 presidential transition, she moved into the opposition and was twice elected Mayor of her hometown (2009–2014; reelected 2014–2022), before voluntarily stepping down to take charge of Senegal's diplomacy. She has served three terms in the National Assembly: first in 2012 in coalition with President Macky Sall; later returning on her own list while at odds with the Socialist Party of Senegal; and again in 2024, nominated on the opposition list led by President Macky Sall.

At the government level, she has held the positions of Minister of Communication (1998), Minister of Foreign Affairs (2020–2023), and Keeper of the Seals, Minister of Justice (2023–2024).

In 2006, she walked the steps of the Cannes Film Festival for Abderrahmane Sissako's Bamako, appearing as herself—an advocate for African peoples confronting harsh adjustment policies promoted under the influence of the IMF and the World Bank—a commitment she continues to uphold.

Hon. Javier Maroto, Senator, Spain; First Vice President of the Senate, is active member of the Parliamentary Network on the World Bank & IMF, he champions stronger financial collaboration across regions and has participated in field visits to projects in Côte d'Ivoire and Jamaica. A former Cabinet minister, Liam served as Chancellor of the Duchy of Lancaster in No 10 Downing Street during the Great Financial Crisis, and in Her Majesty's Treasury where, as Chief Secretary to the Treasury, he designed Labour's fiscal consolidation strategy. When in Opposition, Liam served in a number of frontbench positions, chaired Labour's Policy Review, served on the Council of Europe and founded the All-Party Parliamentary Group on Inclusive Growth, which he chairs.

A former Fulbright scholar at the Harvard Business School, Liam has written twenty books, chapters and pamphlets about economic history, development and foreign affairs. His history of British capitalism Dragons: Ten Entrepreneurs Who Built Britain was published in 2016. He is also the author of Black Flag Down: Counter

Extremism, Defeating ISIS and Winning the Battle
of Ideas; and Turning to Face the East: How Britain
Prospers in the Asian Century. Liam is one of
Westminster's leading authorities on China, helped
kickstart the Economic & Finance Dialogue, and
co-founded the UK-China Young Leader's
Roundtable.
